Borrowers across Texas and New Mexico can receive loan rates below the prime rate that meet the unique needs of churches with flexible terms not offered by commercial financial institutions. As a nonprofit, Texas Methodist Foundation reinvests all of its revenue into the church, growing congregations and building communities.

Loans that Work for You

Construction and Improvement Loans

Provide interim and permanent financing with accurate and timely disbursements.

Property Loans

Fund the purchase of new buildings, land, or parsonages.

Debt Refinancing

Refinance existing debt at competitive rates for up to 20 years.
