## INVESTORS IN IMPACT CERTIFICATES MAKE POSSIBLE A CYCLE OF GENEROSITY

Investing in Wesleyan Impact Partners Impact Certificates enables purpose-driven investors to receive positive returns\* while growing the church's witness nationwide. Impact Certificate investors fund loans to churches and nonprofits and support leaders reimagining ministry and creating new ways to serve communities, creating a cycle of generosity.

Impact Certificates offer investment opportunities to individuals, churches, and agencies, with flexible demand, 1-5-year fixed, and IRA certificate terms. For all Impact Certificates, interest accrues daily and is compounded monthly. For Flexible Demand Certificates and Fixed Term Certificates, investors may elect, at the time of purchase, either (a) to receive semiannual payments within fifteen (15) days after June 30 and December 31 in an amount equal to all interest accrued during the prior six (6) months, or (b) to have interest accrued and compounded until maturity.

### IMPACT CERTIFICATES

<b>Flexible Demand Impact Certificate<sup>1</sup></b>	Provides investors with a variable rate of interest. Withdrawals may be made without any fees or penalties.
<b>Fixed Term Impact Certificate</b>	Offers a fixed rate duration of one, two, three, four, or five years.
<b>Individual Retirement Account (IRA) Impact Certificate<sup>1</sup></b>	Allows individuals to use retirement savings to purchase Impact Certificates and enjoy tax advantages. <sup>2</sup>
